

**DECISION No GB/2022/23**  
**of**  
**the European Cybersecurity Industrial, Technology and Research Competence Centre**  
**Governing Board**  
**on the application by analogy of the Implementing Rules of the Staff Regulations**  
**adopted by the Commission**

THE GOVERNING BOARD,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Staff Regulations of Officials ('Staff Regulations') and the Conditions of Employment of Other Servants ('CEOS') of the European Union, laid down by Council Regulation (EEC, Euratom, ECSC) No 259/68,<sup>1</sup> and in particular Article 110(2) of the Staff Regulations,

Having regard to Regulation (EU) 2021/887 of the European Parliament and of the Council of 20 May 2021 establishing the European Cybersecurity Industrial, Technology and Research Competence Centre and the Network of National Coordination Centres ('founding Regulation'),<sup>2</sup>

Having regard to the rules of procedure of the ECCC and in particular Article 9-11 thereof,

Having regard to Communication C(2014) 6543 final of 26 September 2014 from Vice-President Šefčovič to the Commission on the guidelines on the implementation of Article 110(2) of the Staff Regulations with regard to the implementing rules applicable in the agencies,

Having regard to the fact that the Staff Committee, which is to be consulted pursuant to Article 110(2) of the Staff Regulations, has not yet been constituted, it is impossible at the present to comply with the requirements of that provision. The Staff Committee will be invited to give its opinion on these implementing rules when it has been constituted and due consideration will be given to its opinion. The Governing Board is entitled in such circumstances to approve the rules forthwith,

**WHEREAS:**

- (1) It is necessary to adopt implementing rules for giving effect to the Staff Regulations;
- (2) In application of Article 110 (2) of the Staff Regulations, the decisions referred to in the Annex of this decision shall apply by analogy to the ECCC either nine months after the date of its adoption or by decision of the Governing Board, at an earlier date;

- (3) The ECCC has been unable to establish a Staff Committee because, having been created recently, it has no staff yet. However, it needs to adopt rules on the delegation of the powers conferred by the Staff Regulations on the appointing authority and by the Conditions of Employment of Other Servants on the authority authorised to conclude contracts of employment, in order to start functioning.

HAS ADOPTED THE FOLLOWING DECISION:

*Article 1*

The general implementing rules of the Staff Regulations, as adopted by the Commission, and listed in the Annex shall apply by analogy to the staff of the ECCC.

*Article 2*

This Decision shall enter into force on the day following that of its adoption.
